## Choose the wedding day photo schedule that fits your style & schedule

### ❑ **Option 1: We take Formal Portraits before and after the ceremony**

*Perfect for the Bride and Groom who do not wish to see each other before the wedding. With this schedule option, you will have some formal portraits taken before the ceremony and some afterward.*

Prior to the ceremony, we will take photos of the bride with her family, and groom with his family. Pictures begin **2 hours before** the wedding and end ½ hour before wedding. Bride, Groom, family and wedding party must be dressed and ready for pre-wedding pictures at the scheduled time. Post wedding pictures of the bride and groom together take approx. **1.5 hours after** the wedding. We strongly encourage you to provide hors d'ouvres to your guests while waiting for the pictures after the wedding

### ❑ **Option 2: We take all of your Formal Portraits before the ceremony**

*Perfect for the Bride and Groom who want to go right from the reception to the ceremony. With this schedule the Bride and Groom will see each other before the wedding.*

Bride and Groom are given 5 minutes alone together to share a special moment, and see each other before the pictures. We start taking pictures **2.5 hours before** the wedding (stop ½ hour before wedding). Bride, Groom, family, and all wedding party must be dressed and ready for pre-wedding pictures at the scheduled time. You may leave straight from wedding to reception with no delay for you or your guests.

The schedule options listed above will give you a good selection of formal portraits of the bride, groom, families and wedding party taken at the ceremony location and grounds. We can make arrangements to take additional photos at an off-site location such as a nearby park if your wedding day schedule allows. If you are under time restrictions for your wedding day, contact us to discuss a condensed portrait schedule. We can work with your wedding day schedule and your photography needs.

## Service Terms

- \$50 non-refundable deposit due when reserving day.
- ½ due prior to wedding day, remainder due upon delivery of DVD proofs.
- Prices include up to 1 hour of travel to ceremony location. Additional travel charges apply for ceremony locations beyond 1 hour.
- Extra charges may apply for photography at locations other than ceremony and reception sites (e.g. hair/make-up photos at salon).
- Enlargement orders that are not placed with the album package order are subject to a \$15 charge and current pricing at the time of the order.
- Prices are guaranteed for 6 months following the date of the ceremony. Orders placed after 6 months will be subject to the current prices at the time of the order.
- 6% MI Sales Tax will be added to all orders.

## To reserve your wedding date

1. Submit signed contract (found on page 3 of this document)
2. Submit \$50 deposit (non-refundable). Make checks payable to "Watkins Imaging".



## Contract for Photography Products and Services

This Contract incorporates the entire understanding of the parties. Any modifications of this contract must be in writing and signed by both parties.

**NOTICE OF COPYRIGHT:** Copyrights for services rendered are solely the possession of Watkins Imaging and are protected by Federal Copyright Law (all rights reserved). It is illegal to copy or reproduce the photographs or digital files without the Photographer's written permission, and violators of this Federal Law will be subject to its civil and criminal penalties.

**MODEL RELEASE:** The contracting party grants Watkins Imaging the unrestricted right to use and publish photographs of the contracting party and all guests, for commercial, promotion, competition or other purposes without compensation or liability to the contracting party.

**LIMIT OF LIABILITY:** In the unlikely event that the photographer is injured or becomes too ill to photograph the event, Watkins Imaging will make every effort to secure a replacement photographer. If the situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received for the event package. Watkins Imaging takes the utmost care with respect to exposure, transportation, and processing the photographs. However, in the unlikely event that photographs have been lost, stolen, or destroyed for reasons within or beyond Watkins Imaging's control, Watkins Imaging's liability is limited to the return of all payments received for the event package. The limit of liability for a partial loss of originals shall be a prorated amount of the images lost based on the percentage of total number of originals.

**OMISSIONS:** Due to the uncontrollable nature of wedding logistics, photographing requests may be impossible. While every effort will be made, no requests are guaranteed and Watkins Imaging assumes no liability for omissions.

**SECURITY DEPOSITS:** Upon signature, Watkins Imaging reserves the date agreed upon, and will not make any other appointments for that time period. For this reason all deposits are non-refundable, even if the event is canceled or the date changed for any reason.
